

## Warranty

### STANDARD TWO-YEAR WARRANTY

First Choice Lighting are pleased to offer a 2 year warranty on own brand fixtures.

Our warranty offer will only be applicable if the fittings are considered not to have been mistreated or incorrectly installed.

The customer is entitled to free repair or replacement if the product is deemed to be faulty due to any manufacturing defects in design, material or workmanship within the warranty period upon proof of purchase, when:

- The product defect is reported within two months of its discovery;
- First Choice Lighting is notified in writing of the claimed defects;
- The product defect is acknowledged as such by First Choice Lighting as a result of faulty design, materials or workmanship of First Choice Lighting;
- The Goods or parts thereof claimed to be defective are returned to First Choice Lighting at the risk of the Customer but at the expense of First Choice Lighting.

First Choice Lighting shall not be liable for the failure of any Goods to comply with the warranty set in any of the following events:

- The defect arises because the Customer failed to follow First Choice Lighting's oral or written instructions as to the storage, use and maintenance of the Goods or (if there are none) good trade practice regarding the same;
- The defect arises because of damage caused during installation;
- The defect arises as a result of using spare parts or materials which are not provided by First Choice Lighting;
- The Customer alters or repairs such Goods without the written consent of First Choice Lighting;
- The defect arises as a result of fair wear and tear, wilful damage, negligence, or abnormal storage or working conditions;
- The Goods differ from their description as a result of changes made by First Choice Lighting to ensure they comply with applicable statutory or regulatory requirements;
- The warranty shall not apply to any bulbs, drivers or components supplied by third parties that are incorporated in the Goods;
- Electrical systems in use do not comply with current sector regulations;
- Damage caused by accidents or for reasons of an Act of God, such as: lightning, floods, fires, or impact of environmental, climatic or any other conditions on the product;
- Damage caused by transport;
- First Choice Lighting shall not be liable for damages that may be suffered, directly or indirectly, by individuals, animals and property as a result of not following the instructions or regulations applicable to the installation, use and maintenance of the product.
- The warranty excludes lamps and control gear that fail within expected lifetime margin.
- If First Choice Lighting is unable to replace a defective product with the same it will use all reasonable endeavour to replace with an alternative of a similar specification. Due to changes in specification by LED component suppliers this is not always possible.
- The warranty is invalid if a product is used in a coastal location when it is stated as being unsuitable for this environment.

All First Choice Lighting warranties/guarantees do not cover out of pocket expenses or consequential costs
